

RESOLUTION OF THE BOARD OF EDUCATION OF PETALUMA CITY ELEMENTARY AND PETALUMA JOINT UNION HIGH SCHOOL DISTRICTS ("PETALUMA CITY SCHOOLS"), IN THE MATTER OF THE DECISION TO RELEASE TEMPORARY CERTIFICATED EMPLOYEES, EFFECTIVE JUNE 12, 2024

WHEREAS, the Governing Board is authorized under Education Code section 44954 to give, at any time before the end of the current school year, a notice of release for the succeeding school year to any temporary certificated employee who has served during one school year at least seventy-five percent (75%) of the number of days the regular schools of the District are maintained and to any temporary certificated employee who has served during one school year less than seventy-five percent (75%) of the number of days the regular schools of the District are maintained; and

WHEREAS, the employees listed in Attachment "A" are temporary certificated employees (8.1 FTE) who have served or will serve during one school year at least seventy-five percent (75%) of the number of days the regular schools of the District are maintained and to any temporary certificated employee who has served during one school year less than seventy-five percent (75%) of the number of days the regular schools of the District are maintained; and

WHEREAS, the Governing Board has received a recommendation from the District Superintendent or other appropriate District Administrator(s) to release the temporary employees listed on Attachment "A"; and

WHEREAS, the Governing Board has discussed the recommendation made by the administration and concurs in said recommendation; now

THEREFORE, BE IT RESOLVED, that Petaluma City (Elementary) and Petaluma Joint Union High School Districts Board of Education does hereby adopt that the employees listed in Attachment "A" shall be released from employment at the end of the current school year and hereby authorizes the District Superintendent or the Superintendent's designee to give notice to such employee, in accordance with the requirements of Education Code Section 44954, to such employees of the Governing Board's decision to release them. The District Superintendent or the Superintendent's designee is further authorized to take any other action necessary to effect the intent of this resolution as of June 12, 2024.
