

**RESOLUTION OF THE BOARD OF EDUCATION OF PETALUMA CITY
ELEMENTARY AND PETALUMA JOINT UNION HIGH SCHOOL DISTRICTS
("PETALUMA CITY SCHOOLS"), REDUCING OR DISCONTINUING
PARTICULAR KINDS OF SERVICES BY 8.2 FTE FOR THE 2024-2025
SCHOOL YEAR**

WHEREAS, the Governing Board hereby finds that it is in the best interest of the Petaluma City (Elementary) School District and the Petaluma Joint Union High School District that, as of the end of the 2023-2024 school year, certain particular kinds of services now being provided by the Districts be reduced or discontinued as follows:

1. Eliminate the equivalent of 2.0 FTE Visual & Performing Arts (Elementary)
2. Eliminate the equivalent of 0.4 FTE Visual & Performing Arts (Secondary)
3. Eliminate the equivalent of 0.6 FTE English
4. Eliminate the equivalent of 1.2 FTE Math
5. Eliminate the equivalent of 0.8 FTE Science
6. Eliminate the equivalent of 0.6 FTE Physical Education
7. Eliminate the equivalent of 0.6 Social Studies
8. Eliminate the equivalent of 0.2 Study Strategies
9. Eliminate the equivalent of 0.2 Music
10. Eliminate the equivalent of 0.4 Steps to Success - Credit Recovery
11. Eliminate the equivalent of 1.0 Career Technical Education
12. Eliminate the equivalent of 0.2 World Languages

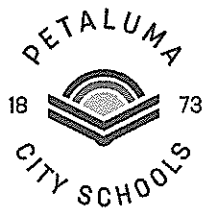
WHEREAS, in the opinion of the Governing Board of these Districts it is necessary by reason of the aforementioned reduction and discontinuance of services to decrease the number of certificated employees by the equivalent of 8.2 full-time equivalent employees for the ensuing 2024-2025 school year; now

THEREFORE, BE IT RESOLVED, by the Governing Board of the Petaluma City School Districts that, as of the end of the 2023-2024 school year the particular kinds of services now being provided by said Districts be and hereby are reduced to the extent hereinabove set forth; and

BE IT FURTHER RESOLVED, that the District Superintendent or Superintendent's designee, be and hereby is authorized and directed to initiate and pursue procedures necessary to not reemploy the equivalent of 8.2 full-time equivalent certificated employees of these Districts pursuant to Education Code sections 44949 and 44955 because of said reduction and discontinuance of services.

The foregoing resolution was introduced by Board Member Sheldon Gen who moved its adoption, seconded by Board Member Mady Cloud and adopted by the following vote:
