NOTES:

• Not all positions are authorized to have a substitute. Exceptions require approval from the

Human Resources Administrator.

- <u>Current employees</u> of the District <u>when employed as a substitute</u> shall receive the hourly rate indicated below:
  - Substituting for the *same position* receive current salary
  - Substituting for a *position never held* receive the substitute rate
  - Substituting for a *position formerly held* receive the step & range last held for this position
  - Substituting for a "like position" same range (IA FI to SOCC and vice versa) receive current salary
  - Substituting for a "like position" in a higher range (IA Spec Ed to IA FI or SOCC) receive "working out of class pay" (see CSEA MOU dated 1/20/04)
  - Substituting for a *"like position" lower* range (IA FI or SOCC to IA Spec Ed) receive current salary
- <u>Former employees</u> of the District, with six or more years of satisfactory service, <u>when employed</u> <u>as a substitute</u> in their former job classifications, or in any lower-range position within the same job category, shall receive the hourly rate applicable to their step placement at their time of resignation, not to include any longevity, professional growth or other stipends the employee may have previously earned. This salary placement practice does not apply to former employees substituting in any higher-range position within the same job category.
